Sub: Allotment of Roll No for Admisstion Test in PG and Integrated Courses and Strict Implementation of Reservation Rules in Admission.

Sir,

We, on behalf of **Assam University SC & ST Employees' Welfare Association**, would like to draw your kind attention to the following few points.

- 1. Recently list of eligible candidates of different academic departments have been uploaded in the Assam University website to appear written test for admission to PG and integrated Courses, 2014. It is observed that most of the departments have allotted Roll nos against eligible candidates indicating respective category like Gen, SC, ST, OBC. This attracts our serious attention and we strongly oppose indication of category in Roll No. Roll No is allotted against a candidate to identify the candidate and it should bear only numerical character not the category. Category is required at the time of final selection of candidates and not at the time of declaration of result of written test, interview etc. Therefore, we request you to instruct respective deptts not to indicate category of the candidate while allotting Roll No. for admission test and if already allotted necessary rectification may be made and uploaded again.
- 2. SC and ST candidates selected on open merit should be placed against unreserved/General seats. In this connection, we like to request you to ensure that Common Merit List be prepared taking General, SC, ST and OBC in order of merit based on written test as well as interview and category wise merit lists are prepared for SC, ST and OBC separately. Unreserved seats should be filled from the common merit list irrespective of category and reserved seats should be filled from the respective category, who are lower in merit left after adjustment of common merit list against unreserved seats.
- Reservation related circular issued from time to time may also be issued to respective HODs for strict compliance admission period

In view of the above, we request you kindly to do the needful to ensure that the reservation policy of GOI and UGC lis strictly followed.
